The following agreement is between "POWER POINTERS/April Syers", hereafter referred to as "BREEDER" & ( YOUR NAME HERE ); hereafter referred to as "PURCHASER", for the sale and purchase of one pure bred German Shorthaired Pointer, from AKC registered parents.

**TERMS:** In consideration of a purchase price of \$1000 of which \$200 is a non-refundable puppy deposit; the Breeder immediately transfers all rights, privileges and responsibilities associated with the ownership of the previously listed dog to the Purchaser on the date specified at the signing of this contract. Puppies can be picked up or shipped at 8 weeks. Any puppy not picked up by 12 weeks will be resold and the deposit will not be refunded. The purchaser is responsible for picking up their puppy or arranging shipping as needed. Shipping can be arranged by the Breeder at the Purchaser's expense. A separate contract is required for shipping as required by the Purchaser. This represents the entire agreement between the Breeder and the Purchaser.

**USE of ANIMAL:** Animal comes with Full AKC registration and may be used for breeding. We agree that the dog is not being purchased for resale of any kind or will it be used or trained for activities that are inhumane or illegal. Such violations will result in the immediate return of animal to Breeder with no compensation to the Purchaser.

**HEALTH:** The Breeder warrants the dog to be in good physical, mental and social health for the first 72 hours. Purchaser agrees to have the animal examined by a licensed Vet. within 72 hours of delivery. A copy of the initial Vet. Examination will be mailed to the Breeder within 30 days of the initial Vet visit. Contract is void if Purchaser does not have the animal examined within the 72 hour requirement or does not provide the breeder a copy of the initial examination within 30 days. Purchaser may return the animal within 72 hours for any reason, provided that the purchaser has not damaged or harmed the animal, for a full refund less the non-refundable deposit. Animal is guaranteed to be free of any life threatening genetic diseases when diagnosed by 36 months of age. No returns or compensation for non-genetic illnesses or injuries. No returns or compensation for cosmetic surgery. No returns or compensation for common internal parasites, fleas or ticks. In the event of a return, Purchaser is responsible for physically returning the animal to the Breeder and/or all shipping and delivery charges to return any animal. In the event of the emergence of any life threatening disorder within 36 months of the animal's birth, which is considered sufficiently serious in the opinion of two unrelated, qualified vets, one of whom will be selected by the Breeder, the Breeder agrees to replace the animal under the following conditions. The original animal must be physically returned to the Breeder at the Purchaser's expense before any replacement animal will be issued. The original animal must be returned without being bred. If the dog has been already been bred, a replacement animal will not be given. Any replacement animals issued, will not have breeding rights. The Breeder is not responsible for arranging or the cost of returning the animal. Upon safe return of the animal to the Breeder, the Breeder agrees to the following. Replace the dog with equivalent breeding from the next available litter. Buyer will be granted a pick from the next available breeding. The replacement animal may not be from the exact same parents. Breeder is responsible for shipping charges of the replacement animal to the purchaser. **NOTE: POWER POINTERS does not refund cash at any time past the 72hr return window.**

**OWNERSHIP REQUIREMENTS:** The Purchaser agrees to maintain the dog in a humane environment and properly train and care for the animal. Specifically the animal will be properly licensed and inoculated for communicable diseases as recommended by a qualified Vet. The dog will not be allowed to roam, and will be properly trained to ensure the Purchaser can safely handle and maintain the animal. By signing this contract the Buyer assumes all risk of loss or injury to the dog as well as cost of transportation and veterinary care relating to the dog's welfare, sale, or possible replacement. No warranty exists pertaining to the future breeding, field, show or work success results from the dog. Breeder is not liable for lost or stolen dogs. The Breeder strongly recommends permanent identification by tattoo or microchip.

**RIGHT OF RECOVERY:** Breeder will provide a permanent home and care to any animal produced by the breeder for the life of said animal. In the event that the Purchaser is unable or unwilling or simply does not want to provide an appropriate home in accordance to the terms of this agreement, the dog will be returned to the Breeder at no compensation to the Purchaser. Purchaser agrees to notify the Breeder in writing if any such contingency arises and will not abandon the animal at a shelter, or sell the animal without written permission from Breeder. If the animal is found to be abandoned, sold, or neglected the Breeder may take legal action against the original Purchaser. The original Purchaser will be held liable for all legal expenses incurred by the breeder to secure the return of the animal's residence to the Breeder. This contract is to be governed by the laws of the State of Oklahoma. Should any legal proceedings need to be pursued by either party, they must be held in the county of Okfuskee in the state of Oklahoma in the United States of America. By signing this contract both the Breeder and Purchaser agree to the terms and conditions outlined in this contract. **Purchaser must have a signed contract present at the time of any dispute to be valid for any refund or replacement animal.**
